Our privacy statement for Minchinhampton Golf Club

Your privacy is really important to us, and we understand how important it is to you. Our aim is to be as clear and open as possible about what we do and why we do it. Minchinhampton Golf Club is committed to the privacy of all its users. We will make every effort to inform you about our privacy policies. Records will be designed, used and stored so as to assure privacy. Legislative controls over records, such as the General Data Protection Regulation (GDPR), will be adhered to.

Who are we:

"We" or "us" Minchinhampton Golf Club Ltd, trading as Minchinhampton Golf Club, a limited company (company registration number: 01057636) whose registered address is Minchinhampton Golf Club, New Course, Minchinhampton, Gloucestershire, GL6 9BE and operating on two sites, the New Courses at Minchinhampton, GL6 9BE referred to as the New Course and the Old Course at Minchinhampton, GL6 9AQ referred to as the Old Course.

Lawful collection of data - what we collect:

For Members

- Name

- A parental / guardian consent form has to be completed with regard to children applications

What we do with the information we gather:

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Internal record keeping.
- We may use the information to improve our products and services.
- We may periodically deliver club news, changes, and information about events and offers to the email address which you have provided, for this we would like members to continue to agree to "opt in"
- From time to time, we may also use your information to send surveys.
- We may contact you by email, phone, fax or mail. We may use the information to customise the website according to your interest

Members agree to opt in when becoming a member but have the right to unsubscribe at any time. By unsubscribing you will remain a club member but will no longer receive any further club news or information.

For Visitors/Customers/Contractors

- Name
- Contact information including email address and physical address
- Other information relevant to your booking
- Other information relevant to the work being done and completed

What we do with the information we gather:

We require this information to understand your needs and provide you with a better service, to manage your booking and for the following reasons:

Internal record keeping

Where customers are contacted with information about services and offers we will ensure that this is in compliance with the GDPR.

For Staff

- Where appropriate qualification and CV information
- HR and recruitment information

What we do with the information we gather:

We require this information for the following reasons:

- Internal record keeping
- We may use the information to improve our products and services with consent

Members and Visitor / Customer information will only be used internally and never shared with third parties.

All customer data will be deleted six months after any enquiry has been dealt with.

Individual Rights

We adhere to the new rights for individuals as introduced by the GDPR in addition to modifications made to current individual rights as covered in the Data Protection Act (DPA).

You may request details of personal information, which we hold about you under the GDPR.

If requested we can make information such as handicap data accessible via a common used machine-readable form such as CSV files.

CCTV

Minchinhampton Golf Club uses CCTV to capture images of individuals or information relating to individuals for Health and Safety and crime prevention.

Data is processed fairly and lawfully and Images of people and the information which is derived from images – for example, vehicle registration numbers, are covered by the Data Protection Act

Recorded material is password protected and stored for a maximum of 60 days.

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

We will not store your personal information for any longer than we need to, however we may be obliged by law to store your communications and personal information including activity logs and we may need to show details of these to government or authorised officials upon request.

All member information is stored off site on an encrypted cloud storage platform. Any information that may exist on internal systems including customer emails are protected by passwords, firewall and kept in a locked room. All physical data is stored in secure locked filing cabinets in a locked office.

How we use cookies

A cookie is a small file, which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.

Links to other websites

Controlling your personal information

You have a right to have your personal data erased to prevent processing in the following specific circumstances:

- Where the personal data is no longer necessary in relation to the purposes for which it was originally collected/processed
- If you wish to withdraw consent
- If you object to the processing and there is no overriding legitimate interest for continuing the processing
- The data was unlawfully processed in accordance with the GDPR
- The personal data has to be erased in order to comply with a legal obligation
- The personal data is processed in relation to the offer of information society services to a child

You may choose to restrict the collection or use of your personal information in the following ways:
